

OFFICIAL RULES AND REGULATIONS

MRS. ESSEX COUNTY HOMEMAKING PAGEANT

The Pageant will be conducted on the Topsfield Fairgrounds, Saturday, October 12, 1985.

To be eligible, a contestant must submit a home baked dessert item, be a married resident of Essex County, currently living with her husband, and at least 18 years of age.

All contestants will be required to arrive at the fairgrounds with their food entry between 9:00 A.M. and 1:00 P.M. on Saturday, the previous week, October 5, 1985. Casual attire is to be worn.

A brief interview will be conducted at this time in the Coolidge Building. The food items will be judged later in the afternoon and the finalists who will be asked to return will be notified. The Pageant finals will take place Saturday afternoon, October 12, 1985 at 2:45 P.M.

All contestants will be judged on the following criteria:

GENERAL APPEARANCE
PERSONALITY
POISE
FOOD ITEM SCORE

The requirements for submitting the food item are as follows:

1. Dessert must be submitted on a disposable dish, either paper or plastic.
2. Refrigeration is not available. Discretion is advised.
3. Food must be completely covered with clear plastic wrap.
4. Two copies of the recipe must be submitted with contestant's name clearly marked on each.

The food item will be judged according to the following criteria:

SKILL REQUIRED TO PREPARE DESSERT
FLAVOR AND TEXTURE
GENERAL APPEARANCE

Entrant agrees that the time, manner and method of judging shall be solely within the discretion of the Mrs. Essex County Pageant Committee and that the decision of the judges will be final.
